Projects Undertaken:

- a) **Project AASTHA:** Conducting sessions on Art, Craft, Self-Defense and Awareness on child sexual abuse that teaches children to defend themselves in any dangerous situations, and helps a child feel more confident about standing up themselves.
- b) **Project WINGS:** Conducting Awareness sessions among the youth (Colleges, work places) about the child exploitation. This project aims to empower, mobilize and sensitize the youth, about their responsibility towards society.

Major Rescue Operations:

Rescued a 13-year-old Drug Addicted Boy: Continuous counseling, building rapport and guidance of 2 months by bringing ourselves to his thinking level, made him to realize the wrong step he has taken. After 2 months, he came to us saying "I want to become a scientist and stop all my bad habits"

Rescued a 3-year girl, beaten brutally by her parents: The girl was taken for begging and mis utilized to create sympathy for begging. Her father's drinking habit led to stab her eye with sharp object. The team rescued and provided her the safe shelter.

Rescued an exploited 3-year-old boy: He was ill treated by his step brother and was never given enough food. They isolated him. Team rescued and provided him safe shelter.

Shelter and education for a 5-year girl: The girl had a single parent. Mother is a maid. She was not supported to go to school. Team joined her to school along with providing the educational expenses.

Helped in providing shelter and education for a 7-year old girl and 10-year old boy: They were living in an unsafe place, which was almost like a forest, and never went to school. Team rescued and joined them to school along with their study expenses.

Rescued children from begging at slum places and joined them to school

Rescued children from bonded labor and joined them to school convincing their parents

Help Desk at Slum, headed by a woman to follow up Child Welfare.
